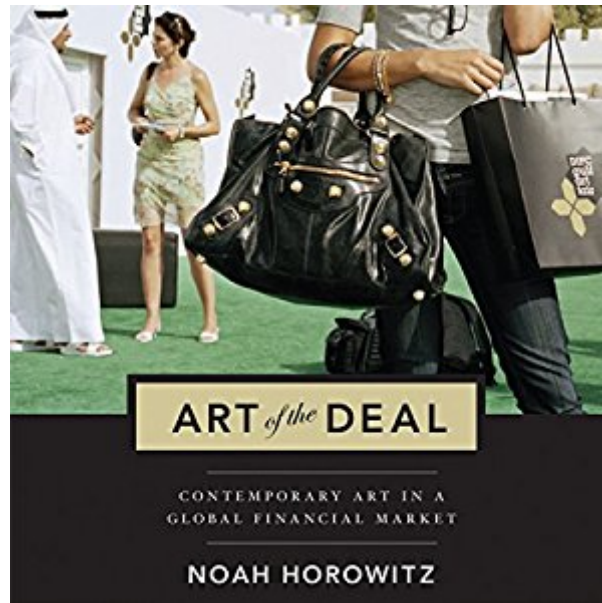

I finished the book astonished that something similar had not been written long ago--after all we live in a world where understanding market behaviour is no longer desirable but a must! Although the book cannot be said to be easy reading to the layman reader, testing our understanding of both cutting-edge art historical theories and complex financial factors, it is nonetheless a highly enjoyable read. I especially found myself amused when reading the chapter on experiential art: Indeed, how does one price an art work consisting of the artist cooking a meal and leaving the messy kitchen behind!? Having read Noah Horowitz' book, I can now say that I better understand the Art of the Deal!

An accessible, informative and highly enjoyable read. It's a great look at the contemporary art market with enough story-telling and background that I felt like an insider by the end, despite being just a casual art observer. I received as a gift and it's been a hit for everyone I've done the same for.
