

Upon looking this up under the Help section for Kindle, I found that there's a way to tell if there are page numbers on the page, but no one told me about this caveat when I bought it. This book was extremely disappointing to me because it has missed so much of what health promotion could be and do in clinical settings. Despite defining health promotion in terms of community early in the book (although it completely misses the Ottawa Charter), there is almost no understanding of how hospitals can play a role in developing community health. The focus of the chapters is far more on providing patient education - which is not really health promotion at all.
