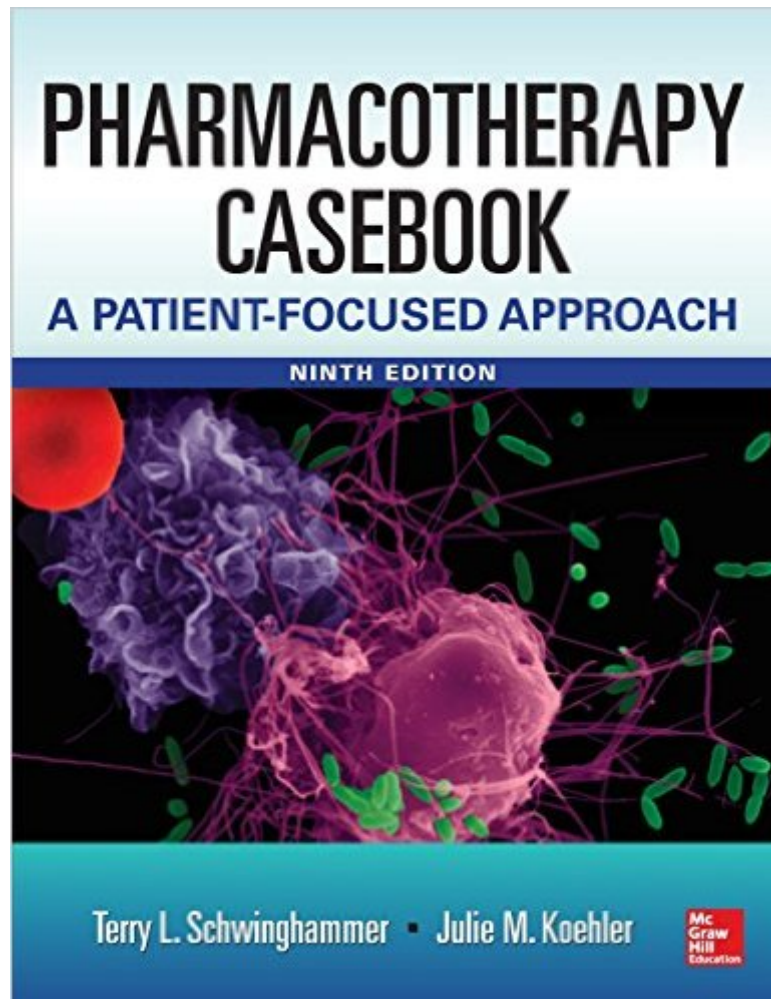

I was hugely disappointed and forced to find other means to gather the much needed information. Who ever sent this book should be ashamed for taking someone's money knowing an entire section was missing. If you zoom in on my picture you will see it goes from page 104 straight to page 137. This is unacceptable considering I also paid for an expedited item.

The book has no solutions just some cases without answers to the questions/cases..it's useless to me unfortunately I discovered that late otherwise I could have returned it back.I bought it to help in my NAPLEX exam.

The case studies are great, wish there was an answer key or suggestions for appropriate treatments somewhere so that I knew I was on right track.
